**NOTICE OF 90-DAY PERIOD FOR PROTEST OF FEES**

Pursuant to Section 66020 of the California Government Code and other applicable law, you have a period of ninety (90) days from the date of payment of school fees, mitigation payments or other extractions to protest the validity thereof. This ninety (90) day period commences upon such payment of performance of any other requirement, as provided in Section 66020. Any such protest must be in writing and received by Barstow Unified School District within ninety (90) calendar days of the date of the School District Certification above.

**EFFECTIVE PERIOD OF CERTIFICATE OF COMPLIANCE**

This certificate of Compliance is valid for a period of ninety (90) days from the date of issuance. Upon application by the Applicant, the Board of Education of Barstow Unified School District may determine, in its sole discretion, that good cause exists to grant an extension to the foregoing period. The Board may grant an extension for any number of days up to and including thirty (30) days. The Applicant may apply for up to three (3) such extensions. At such time as this Certificate of Compliance expires, if a building permit has not been issued for the construction of the corresponding DU, the Applicant will be reimbursed all amounts paid, without interest, that were paid to obtain this Certificate of Compliance. This Certificate of Compliance shall be deemed to be a separate Certificate of Compliance for each Lot/DU specified above.
